### Disclosure of personal data to third parties

The Association will only disclose your data to third parties if this is necessary for the implementation of the agreement you have with the Association, unless the Association is obligated by law to disclose your data to these third parties. In the aforementioned chart you will find an overview of situations in which personal data are disclosed to third parties.

### Access, correction and disposal of personal data

You have the right to request access to your personal data (unless the Association is not obligated to grant this access on the basis of the Algemene Verordening Gegevensbescherming (AVG)) and to let your data be complemented, disposed of or foreclosed. You are to identify yourself in the case of such a request. Should you

wish for your personal data to be disposed of, then the Association shall give notice of this disposal to all third parties that have received these data.

### **Protection of personal data**

The Association takes adequate measures to protect your personal data against loss, unauthorised access, publication and unlawful processing. In this way, we make sure that only the necessary parties have access to your data, that the access to all personal data is foreclosed and that our safety measures are checked upon regularly.

### **Minors**

You are to request for explicit permission of a parent or guardian in case you wish to register as a minor.
